Public Comment: On whether to making indoors optional

Penny Collins (comments were submitted in advance): expressed strong support for making masks optional indoors. Need to keep focus on safety. Would like to adopt CDC recommendations.

Jennie and Nathan Raby: School has been a bastion of safety; we have seen a decrease in cases; Nathan: my preference is to continue with masks for a few more weeks - this is a big experiment and we do not know how this will play out. Appreciate the caution the school has demonstrated. Don't jump on the bandwagon but wait a few weeks longer. Jennie: Fully support extending the indoor mask mandate.

Amy Philips: In support of optional masking and continued situational discretion in response to testing.

Stacy Williams: I'd love to see masks become optional now that numbers are so low Elisha Anderson: The board has always followed CDC and DOE GUIDELINES; Nothing else should matter. You are making personal opinions board guidelines If a family feels they need to mask they have the ability to. Our kids are all over each other outside so there goes the whole argument on avoiding droplets. We are in the green. The school is 3 weeks 100% negative pooled testing- Cumberland and Androscoggin are GREEN

From Megan's iPhone to Everyone:There are more counties than just Cumberland and Androscoggin. Portland schools are still masking.

From Elisha Anderson: Portland is optional. And the majority of our students are in Cumberland and Androscoggin

From Amy Phillips: Just to remind everyone we do pull from 3 counties

From Penny Collins: Portland has gone to optional masking, We are like 90% Cumberland and Andro.

From Megan's iPhone: Maybe so but I'm located In Oxford County and my child counts I really think we need to listen to the medical professionals- and how school is going we have been negative!

From Elisha Anderson: Oxford is green

From Amy Phillips: I'm going to head out, but I cannot express enough how much it means the amount of effort and consideration that is going into the healthy and safety of our kiddos

Executive Director Report

In addition to the Executive Director's report, Jacinda walked through the process of addressing the pandemic for the last 2 years and expressed gratitude for the heroic efforts of all involved.

Highlights: Lottery - very successful; had some of the highest numbers - 22 on the waiting list for pre-k, almost as high for other classes. Will have the first violin concert this spring (mostly outside) for 52 young violinists(!); 25 students in private music

lessons; 8th Grade graduation scheduled; staff benefits package rolled out; rolled out 'infinite campus' data support system.

Informational

Committee Updates

Health Committee: Sally Morris and Susan Doughty (committee chair) presented information and recommendations for implementing new Covid protocols e.g., optional masking, and walked through a powerpoint presentation. Health COmmittee recommended continuing with indoor masking.

Board Discussion:

Ben - risk and balance has shifted, but that is no longer the deal breaker; we need to continue to be cautious; with Spring coming we need to be spending more time outdoors; let the parents and the kids decide whether to mask indoors. In fill support of ending the indoor mask mandate.

Kim -We have children in the school that are not eligible to be vaccinated, and I wish more of our kids were vaccinated, which would make this an easier decision. That is a large part of the struggle - if more kids were vaccinated this would be a different conversation.

Joe - this is a dilemma - it's right vs right; our policy makers should have had this same data as we are considering, so I have a hard time not to follow the guidelines of the Governor and policy leaders. For almost 2 years we have been following the guidelines from our leaders and should continue to do so. Parents should be exercising their choice and the option to mask or not. In support of ending the indoor mask mandate.

Susan - we need to look at the data and where it is coming from; pre-Delta the masks started coming off but when we looked to UK and Europe and the surge. We are now seeing a very infectious variant that is clearly surging. If we decide to take masks off it will be a very short time period before masks are back on.

Carolyn - in favor of making masks optional, with the proviso that the health committee continue to review the health data to make recommendations as appropriate. We should continue to rely on CDC and DOE guidelines as we have in the past.

Sally: Part of what we are struggling with is there is no deciding formula/matrix. Committee's reasoning - the community wide risk factor is what tipped the argument. The masks alone are not the problem. The data that is being reported is being reported faster than what is being adopted by government agencies. The kids have been wearing the masks for two years and have done well. There are two sides of the argument, but we are all in agreement in general on one point: We all want to get to "indoor masking optional". The question is when. And if metrix change we have to change our policy.

Becky: Pre k needs to be considered separately as the majority is ineligible for vaccination.

Policy needs to be updated regarding pooled testing
